Website Terms and Conditions



Part A. General user terms

1. Your acceptance

(together, the Websites).

- (b) view and interact with any content, information, communications, advice, text or other material provided by Diabetes WA (**Diabetes WA Content**) or any User Content (defined in clause 5.1); and
- (c) upload User Content to the Websites and communicate with Diabetes WA.
- 1.2 You agree to be bound by these Terms when you use, browse or access any part of the Websites.
- 1.3 Diabetes WA may from time to time review and update these Terms including to take account of new laws, regulations, products or technology. Your use of the Websites will be governed by the most recent Terms posted on the Websites. By continuing to use the Websites, you agree to be bound by the most recent Terms. It is your responsibility to check the Websites regularly for updated versions of the Terms.

2. Changes to the Website

2.1 The Websites are subject to change at any time without notice and may contain errors.

3. Diabetes WA Content

We will issue you with a refund if your credit card has been charged or we have received payment from you, and your order is cancelled by us.

- 18.5 You must notify us immediately if you become aware of any unauthorised access or use of your Account.
- 18.6 You agree that you will not create more than one personal Account using the same email address and if we disable or terminate your Account for any reason, you will not create another one without our permission, whether through the use of your own personal details or those related to you or created by you.

19. Payment

- 19.2 Your order will be delivered to you using one of our third party couriers.

- 19.4 We accept Online Payment via using PayPal, VISA or MasterCard.
- 19.5 If you choose to pay by credit card, you authorise us to debit the amount that is payable for an accepted order from your nominated credit card account.
- 19.6 If we are unable to successfully process your credit card for your order that is accepted by us, then we may cancel your order.
- 19.7 You must not pay, or attempt to pay, for orders through any fraudulent or unlawful means.







- 19.8 We will provide you with a receipt at time of confirmation of the order (in respect of Online Payments) which specifies the total fees and charges for the products and services in your order.
- 19.9 Any specific terms and conditions of supply for any products or services purchased via the Websites will be notified to you via the Websites before you finalise your order. Your confirmation of any order indicates your acceptance of those terms and conditions of supply, which will upon confirmation of the order be incorporated into these Terms in respect of that order.
- 19.10 You may be entitled to concession pricing in respect of the Diabetes WA Products and Diabetes WA membership subscriptions offered via our Websites if you are a member of the National Diabetes Service Scheme or Diabetes WA or hold a seniors, pensioner, Department of Veterans Affairs, healthcare card or student card. You must quote your concession details at the time of placing your order to receive concession pricing for such Diabetes WA Products or Diabetes WA membership subscription.

20. Indemnity

- 20.1 You will fully indemnify Diabetes WA in respect of all loss, damage, costs, expenses (including legal fees on a full indemnity basis), fines, penalties, claims, demands and proceedings howsoever arising, whether at common law (including negligence) or under statute, in connection with any of the following: (a) any breach of these Terms by you;
 - (b) your use of the Websites;
 - (c) your communications with Diabetes WA;
 - (d) User Content you upload on the Websites; or
 - (e) any third party use of the Websites through your Accounts (whether authorised or not).

21. Warranties, consumer guarantees and limitation of liability

- 21.1 Subject to clause 21.2, any representation, warranty, condition, guarantee or undertaking that would be implied in these Terms by legislation, common law, equity, trade, custom or usage is excluded to the maximum extent permitted by law.
- 21.2 Nothing in these Terms excludes, restricts or modifies any consumer guarantee, right or remedy conferred on you by the Australian Consumer Law being Schedule 2 to the *Competition and Consumer Act 2010 (Cth)* (**ACL**) or any other applicable law that cannot be excluded, restricted or modified by agreement.
- 21.3 To the fullest extent permitted by law, the liability of Diabetes WA for a breach of a nonexcludable guarantee referred to in clause 21.2 is limited, at Diabetes WA's option, to:
 - (a) in the case of goods supplied or offered by us, any one or more of the following:







- (i) the replacement of the goods or the supply of equivalent goods;
- (ii) the repair of the goods;
- (iii) the payment of the cost of replacing the goods or of acquiring equivalent goods; or
- (iv) the payment of the cost of having the goods repaired; or
- (b) in the case of services supplied or offered by us:
 - (i) the supplying of the services again; or
 - (ii) the payment of the cost of having the services supplied again.
- 21.4 Diabetes WA will not be liable to you for any indirect, incidental, special or consequential loss or damage, loss of profits or anticipated profits, economic loss, loss of business opportunity, loss of data, loss of reputation or loss of revenue (irrespective of whether the loss or damage is caused by or relates to breach of contract, tort (including negligence), statute or otherwise) arising in connection with the Websites, the Diabetes WA Content, all links to or from the Websites or the goods and services advertised or referred to on the Websites.

Subject to this clause, the maximum aggregate liability of Diabetes WA for all proven losses, damages and claims arising out of or in connection with these Terms or a supply under these Terms, including liability for breach, in negligence or in tort or for any other common law or statutory action, is limited to the sum of \$100.

23.1 These Terms are governed by and must be construed in accordance with the laws of the State of Western Australia, Australia. You submit to the exclusive jurisdiction of the courts of that State and the Commonwealth of Australia in respect of all matters arising out of or relating to these Terms, their performance and subject matter.

24. International use

24.1 We make no representation or warranty that any competition, offering or content accessible through the Websites is appropriate or available for use in locations outside Australia. If you







- choose to access the Websites or our products and services from other locations, you do so at your own risk and are responsible for compliance with all applicable laws. You are not authorised to access the Websites from any location where doing so would be illegal.
- 24.2 You understand that some countries have import restrictions on certain goods or materials. If you are outside Australia, you will be responsible for checking whether such restrictions apply before uploading User Content or accessing our products and services. If you are outside Australia you will become the importer and will be liable to pay local taxes or duties, and you will assume all liability under any customs or import laws and regulations.

25. Severability

25.1 Each provision of these Terms is severable from the others and no severance of a provision will affect any other provision.
